FEDERATIONS INVITED	The “Cascais Beach Cup” is an international event, open to all clubs affiliated in the respective Federations as well as Representatives of National Federations, District or Regional associations.						
AGE LIMITS	Junior: as per FIG technical regulations Open Senior: as per FIG technical regulations All gymnasts must have a valid FIG licence until the end of the event.						
JUDGES AND JURIES	<p>All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.</p> <p>It is compulsory that the participating Delegations to include in their delegation at least one (1) judge with FIG current valid brevet. The number of judges to be presented by the delegation is determined by the total number of entries in all apparatus:</p> <ul style="list-style-type: none"> • 2 to 10 entries = 1 judge • 11 to 20 entries = 2 judges • 21 to 35 entries = 3 judges • 36 or more entries = 4 judges <p>The Clubs, Associations or Federations that don’t oblige by the established rules relating to the disposability of judges will be penalized with the payment of 450 Euros (four Hundred fifty Euros) for each missing judge. The non-payment of the penalization will implicate the non-participation in the event of the respective competitors. All the judges indicated by the respective Clubs, Associations and Federations to the organization, will have to be present at the respective judge’s meetings. Note: Transport, accommodation and meals of the judges of each delegation are of the respective delegation’s responsibility.</p>

ENTRY FEES	<p>The cost for the entry fee is €20 (twenty euros) per gymnast in Individual Trampoline, tumbling or Double-mini Trampoline, €35 (thirty-five euros) per gymnast that apply for two apparatus. €50 (fifty-euros) per gymnast thar apply for three apparatus. The entries for the Team Competition are free of charge Entries will be considered on a first come first served basis. Entry (Use online entry or Forms on www.beachcup.pt)</p>						
ACCREDITATION	<p>Delegation accreditation will take place upon arrival. For accreditation, Heads of the Delegations are required to bring the following documents:</p> <ul style="list-style-type: none"> • Passports of all members of the delegation; • Proof of total payments; • Proof of medical insurances; <p>All financial obligations must be fulfilled before arrival or during the accreditation. Accreditation card is personal for each of the delegation members. Accreditation card wearing is required at all times of the tournament.</p>						

	<p>NOTE: The LOC will be responsible for Checking the validity of the gymnast' Licenses. No gymnasts will be accepted without a valid License at the deadline of the Nominative Registration and until the end of the event. The LOC will distribute information regarding the gymnasts' safeguarding plan</p>
EVENT FORMAT	<p>PARTICIPANTS The "Cascais Beach Cup" is an international event, open to all clubs affiliated in the respective Federations as well as Representatives of National Federations, District or Regional associations. The Trampoline International Competition will consist of Individual Trampoline, Tumbling and Double Mini-Trampoline with Qualifications and Finals. Each gymnast can only participate in one group in each of the classes.</p> <p>Participation in the Qualifications:</p> <ul style="list-style-type: none"> • All competitors must take part in the qualifications. • In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied. <p>FINALS FIG rules for qualifying for semi-finals, if applicable, and for finalists. Tie-breaking rules as per FIG/WAGC in valid Code of Points.</p> <p>Team The teams ranked in 1st, 2nd and 3rd place in the team competition will receive a trophy. The top 3 final results, from elements of the same team, in Individual Competition obtained at the Qualifying round will be added together to get a total score and determinate the team ranking. There are no team final. Each Club may register more than one Team. The constitution of the Team cannot be changed in any of the APPARATUS and will be defined until the moment of nominative registration.</p>

INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. SAFEGUARDING	<p>From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.</p> <p>In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>
